Al was enrolled in the ROTC program while attending the University of Idaho in Moscow



trips in their fifthwheel trailer. Gathering and cutting firewood for the home wood stove and going fishing were some of Al's favorite things to do.

Al was preceded in death by his parents, Henry Milton and Veva Greene Hammill; sister Arlene Hammill Corn; and brother Louis Hammill.
