charter using the League of Oregon Cities model charter as a template. Some of the

changes include:

1) The charter's language was modernized, replacing male pronouns with gender-neutral ones and outdated terms with more current vocabulary (i.e. "minutes" instead of "journal of proceedings").

 Absence from 50 percent of council meetings in a calendar year, moving out of the ward the councilor was elected to represent and unauthorized release of executive session material were added to the list of reasons the council can remove a city councilor or mayor from their seat. The council also replaced the words "conviction of a felony" with "conviction of a public offense punishable by loss of liberty" so as to include serious misdemeanors like assault.

3) The city manager is now required to reside in the city.

4) A largely ignored clause requiring city councilors to be a "freeholder upon land" (property owner) was taken out.
